- City Ordinance requires vehicles to be licensed and in working order
 - o Any unlicensed vehicle must be inside
 - No exceptions for a commercial property, such as auto body shop
- Vehicles outside are customer vehicles
 - Moving from St. Peters location
 - Plan is to fence area, not viewable from street
 - Typically, vehicles will be inside when being restored

Suggestion(s):

- Request for a 90 day special use permit with stipulation that no abandoned or unlicensed car shall be on the property longer than 30 consecutive days or it must be covered (i.e. car cover). Within this, we request a plan for improvement that includes a timeline for completion 1 year from the issuance of the permit.
